General Conditions for Eligible Tenderers			

SI No	Conditions
1	The contractor should have registered as forest contractor in office of the Deputy Conservator of Forests, Cauvery Wildlife Division, Kollegal for the year 2022-23 before the Last date of Bid submission and upload a copy of the Registration certificate in e-Procurement Portal. The terms of Registration should be on par with the circular issued by Prinicipal Chief Conservator of Forests (HoFF), Bangalore vide Letter No. KFD/HoFF/HQC(PA)/1/2022 dated 09-05-2022. As mentioned in the table below
2	Tenders from Joint ventures are not acceptable, Conditional tenders will not be accepted.
3	Bidders shall not be under a declaration of ineligibility for corrupt and fraudulent practices issued by Government of Karnataka
4	The Bidder shall ensure credit of Tender Processing Fee and EMD into the respective receiving bank accounts of e-Procurement on or before the last date of bid submission. The EMD amount is 2.5% of the estimated amount.
5	The tenderer is required to ensure browser compatibility of the computer well in advance to the last date and time for receipt of tenders. The departments shall not be responsible for non-accessibility of e-Procurement portal due to internet connectivity issues and technical glitches.
6	The details of works shown in the estimates/data sheet are indicative, they may change based on field conditions and other factors.

7	The tenderer shall bear all costs associated with the preparation and submission of his tender, and the employer will in no case be responsible and liable for those costs.
8	The cost of the Tender processing fee shall not be refundable. The employer is not responsible for any delay in accessing E - Procurement Portal. Applicable taxes will be deducted as per prevailing Government orders.
9	All scanned original documents to be uploaded and the Deputy Conservator of Forests, Cauvery Wildlife Division, Kollegal reserves the right to verify the documents before approval.
10	The employer reserves the rights to Reject or accept any or all the tenders without assigning any reasons.
11	In the case of the death of the contractor after executing the agreement / commencement of the work, his legal heir, if is an eligible registered contractor and is willing can execute and compete the work at the accepted tender rates irrespective of the cost of the work.
12	The successful Tenderer shall deliver to the Employer a Security deposit for an amount equivalent to 5% of the Contract.
13	Contractor should carryout additional test required to test the suitability of materials. Contractor should follow strictly the prevailing rules of labour Act.
14	All precautions should be taken by the contractor so that there are no damages to such public/ private properties.
15	Tenderer shall enclose duly attested copies of audited copies of accounts for the years 2017-18, 2018-19, 2019-20, 2020-21 & 2021-22.

16	Further particulars like detailed estimates, detailed conditions, if any, required by the Contractor can be had from the office of Deputy Conservator of Forests, Cauvery Wildlife Division, Kollegal during office hours on all working days.
17	Contractor should adhere to HSE (Health Safety Environment) policy applicable for similar projects. Contractor to that extent should submit HSE document defining all the procedure including the policies before execution of the project.
18	The estimate indicated in the Schedule-B of the e-procurement platform is tentative and is subject to the approval of the competent authorities.
19	The competent Authority i.e. Deputy Conservator of Forests, Cauvery Wildlife Division, Kollegal reserves the right to make modification with regard to the estimate based on the field requirement and the estimated amount may vary according to the cost norms or allotments received to the concerned works.
20	Payment will be done based on the scrutinized and sanctioned estimates and the check measurement by the competent authority as per the forest codes.
21	The Deputy Conservator of Forests, Cauvery Wildlife Division, Kollegal will be the final authority with regard to the evaluation of technical qualification criteria.
22	Irrespective of the date of completion of the work the payment will be done to the successful tenderer only as per the approved SSR rates of concerned department for the concerned year and the rate quoted by the successful tenderer. No escalation in the rates quoted would be considered.

23	Each work will have to be completed within specified period mentioned in the work order.
24	The competent authority i.e. Deputy Conservator of Forests, Cauvery Wildlife Division, Kollegal shall have the right to cancel the entire process of tender through e procurement without assigning any reason whatsoever. In such circumstance, the tenderer shall not be eligible for any interest on the EMD amount paid by him. Further the Deputy Conservator of Forests, Cauvery Wildlife Division, Kollegal would not be liable to pay any cost which the tenderer may have borne with regard to the submission of the tender and its processes. In case of cancellation of the tender, the Tender Processing Fee paid to the e procurement platform is not refundable.
25	Some of the mentioned works in the tender are called on expecting the issue of allotment. However if the allotment are not received to the particular works, then the tender will be cancelled as per the above condition.
26	Sanctioned Estimate and approved plan will be given at the time of Agreement.
27	The Tenderer should submit a certificate in valid bond paper duly attested by Notary for not being black listed in any Forest Division or any Government Office.
