1	Bidder shall pay Contract Management Module processing fees of 0.025% of the contact value (Min Rs.500/- & Max Rs.7500/-) soon after contract has been issued to bidder.

3	Bidders shall not be under a declaration of ineligibility for corrupt and fraudulent practices issued by Government of Karnataka
4	The tenderer is required to ensure browser compatibility of the computer well in advance before the last date and time for receipt of tenders. The departments shall not be responsible for non-accessibility of e-Procurement portal due to internet connectivity issues and technical glitches.
5	Eligible tenderers may submit tender for the work
6	Conditional tender will not be Considered
7	Within 3 days of receipt of the letter of acceptance, the Successful tenderer shall deliver to the employer a security deposit in any of the form given below for an amount equivalent to 5% of contract price plus additional security for un balanced tenders in accordance with clause 25.5 of ITT and clause 45 of conditions of contract 1. Bankers cheque/DD/pay order in favour of EE RDW&S Division payable at Bagalkot (Nationalized/Sechduled bank) in the form given in Section 10 or Specified small savings instrument pledged to EE RDW&S Division Bagalkot.

25	Bidder should possess construction equipments like JCB, Tipper, Tractor, Concrete Mixer, Vibrator, Weigh Batchers, Hydraulic Testing Equipments & other like centering plate & all other equipments he should submit the details of equipments possessed by him & equipments taken on rent by a rent agreement. Rent agreement should not be more than 6 months old.
