General Conditions for Eligible Tenderers		

SI No	Conditions
1	Tenders from Joint ventures are not acceptable.
2	Bidders shall not be under a declaration of ineligibility for corrupt and fraudulent practices issued by any State Government / Government of India /Union Territory.
3	It shall be the responsibility of the Bidder to ensure credit of Tender Processing Fee and EMD into the respective receiving bank accounts of e-Procurement on or before the last date and time of bid submission.
4	The bidder is required to ensure browser compatibility of the computer well in advance to the last date and time for receipt of tenders. The departments shall not be responsible for non-accessibility of e-Procurement portal due to internet connectivity issues and technical glitches at bidder's end.
5	EMD Payments through e-Payment mode shall be made as one single transaction and payments made in part are liable for rejection.
6	Bidder shall pay Contract Management Module processing fees of 0.025% of the contact value (Min Rs.500/- & Max Rs.7500/-) soon after contract has been issued to bidder.
7	Sub-Leasing/G.P.A of Work is Prohibited.
8	Contractor has to make his own arrangement for procurement of all materials required for the work. There is no departmental supply of materials. Contractor should procure only ISI mark materials and submit necessary quality control certificates from the authorized quality control authority, before execution.
9	1% Bill Amount of the Successful Tenderer will be deducted as Labour cess

10	The contractor must upload existing commitment of the ongoing works in hand for the calculation of tender capacity .Tenders failing to submit the existing commitment details in hand are liable for rejection.
11	The employer reserves the right to accept or reject any of the tender without assigning any reason
12	The Defects liability period is 1 years. The contractor is liable to rectify the defects in the work done up to a period of 1 Year from the date of completion of the work at his cost.
13	Failure of the successful tenderer to comply with the requirements of sub clause 29.1 shall constitute sufficient grounds for cancellation of the award contract and action will be taken as per GO Aae 675 veccha-12/2020, Bangalore Dt: 22.12.2020.
14	Royalty charges will be deducted as per the rates prevailing at the time of execution of work.
15	The Tenders are invited as per Standard tender Bid Document KW-4, The tenderer should go through all the tender conditions and should upload original document, commitment agreement in prescribed format as given in Std bid Document.
16	Conditional tender will not be considered.
17	Tender Processing Fee will not be refundable.
18	All relevant documents as per KW-4 need to be uploaded while submitting bid in general document provision in E-procurement portal.

19	The rates quoted shall be for finished items of work inclusive of all lead and lifts, loading and unloading charges, all incidental charges and all taxes, local or general royalty etc., complete payable to the Government or local bodies in the region.
20	'The contractor shall quote the rates without adding GST for either materials or works contract(service).GST payable by the contractor under this works contract will be paid to the contractor over and above the contractors bid amount'
21	Adjustment toward the contract price shall be effective on the cement and steel used in the work ,as per the government order No: FD 03 PCL 2008 dated: 21.11.2008. and circular No:PWD 159 CRM 2009 Dated: 30.09.2010.from the secretariate KPWD Bangalore
22	The Executive engineer, reserves the right to accept or reject any Tender, and to cancel the Tender process and reject all Tenders, at any time prior to the award of Contract, without there by incurring any liability to the affected Tenderer or Tenderers or any obligation to inform the affected Tenderer or Tenderers of the grounds for the Employer's action.
23	Typographical errors if any will not be the ground for any claims by the contractors.
24	GST & EPF registration certificate from competent authority is compulsory.
25	IT & GST will be deducted as per Government orders.

26	Contractors have to produce all the original documents whenever employer calls for verification. otherwise the tenders will be treated as Non-responsive & liable for rejection.
27	Contractors have to upload the Certificates of works in hand of any Department/Institutions failing which the tender will not be considered. Action will be taken as per clause 31 of SECTION 2: INSTRUCTIONS TO TENDERERS (ITT) in case of incomplete/ false documents regarding works in hand.
28	During the execution of works, if any minor minerals are required, contractors have to abide by the prevailing rules and Acts applicable to Minor Minerals. As per the prevailing rules, for any use of Minor Minerals, the contractor has to submit the Mineral Dispatch Permit (MDP) obtain from Mines and Geology Department.If Mineral Despatch Permit (MDP) is not submitted by the contractor along with the bill, the prevailing penalty DMF contribution as per Karnataka Minor Mineral Concession Rules 1994 (as amended from time to time) will be deducted from the contractor's bill.
