SI No	Conditions
1	Tenders from Joint ventures are not acceptable
2	The intending bidder should furnish the relevant class certificate of registration issued by State/Central and certificate of enrollment in CNNL
3	Bidders shall not be under a declaration of ineligibility for corrupt and fraudulent practices issued by any State Government / Government of India /Union Territory
4	It shall be the responsibility of the Bidder to ensure credit of Tender Processing Fee and EMD into the respective receiving bank accounts of e-Procurement on or before the last date and time of bid submission
5	EMD Payments through e-Payment mode shall be made as one single transaction and payments made in part are liable for rejection
6	The bidder is required to ensure browser compatibility of the computer well in advance to the last date and time for receipt of tenders. The departments shall not be responsible for non-accessibility of e-Procurement portal due to internet connectivity issues and technical glitches at bidders end
7	Bidder shall pay Contract Management Module processing fees of 0.025% of the contact value (Min Rs.500/- & Max Rs.7500/-) soon after contract has been issued to bidder
8	Conditional tenders will not be accepted
9	The tenderer shall bear all costs associated with the preparation and submission of his tender, and the employer will in no case be responsible and liable for those costs

10	The Tender processing fee shall not be refundable
11	As per Karnataka state Government order LD/300/LET/2006 Bangalore dated 01.01.2007 and Government letter no PW/134/BMS/2007 dated 27.07.2007, a sum amounting to 1% of the bill amount will be deducted towards constructions labour welfare fund
12	All scanned documents to be uploaded shall be in original and the Executive Engineer reserves the right to verify the documents before approval
13	The employer reserves the rights to Reject or accept any or all the tenders without assigning any reasons.
14	The contractors assessed available tender capacity will be calculated as per the clause 3.1 of STD tender document Attached
15	All the items in the tender include all lead, lifts, loading unloading, transportation, labour, hire charges of machinery curing for concrete works, cost and conveyance of all material and all other such incidental charges necessary for successful completion of works as per the detailed technical specification and direction of Engineer in charge of this work
16	All precautions should be taken by the contractor so that there are no damages to such public/ private properties.
17	Materials like steel, cement etc., required for the work shall be procured by the tenderer themselves and should got tested by the quality control authority before use on the work at their own cost

18	Contractor should take all precautionary measures to avoid any damage to the utilities during excavation as well as utility shifting. To that extent the contractor should indemnify the client
19	Defect liability period depending upon nature / type of work is as under; a) For all the cross drainage works aqueducts/ embankment and other works costing less than Rs. 50 Lakhs the defect liability period is 3 years from the date of completion of the entire work. b) For all cross drainage works/aqueducts/embankment and other works costing more than Rs. 50 Lakhs the defect liability period is 5 years from the date of completion of the entire work. c) For all types lining and other works the defect liability period is 3 years from the date of completion of the entire work. d) For works like road, silt and other small works which will be taken up out of * maintenance grant the defect liability period shall be 3 months from the date of completion certificate and shall not be later than 6 months from physical completion of the entire work.
20	Royalty on construction materials and other taxes will be deducted as per prevailing Government orders
21	Contractor should follow strictly the prevailing rules of labour act
22	The required documents listed under Sections 3 5 and 8 shall be filled and complied in without exception If any of the documents mentioned in Section 3 are not uploaded the Tenders of such Tenderers shall lead to rejection as Non-Responsive

23	Contractor should adhere to HSE (Health Safety Environment) policy applicable for similar projects. Contractor to that extent should submit HSE document defining all the procedure including the policies before execution of the project
24	Contractor should take all precautions to ensure that no damage is caused to the existing structures which have been constructed by other agencies during project execution. If any damage is caused, it has to be rectified at his own risk and cost
25	Prevailing GST shall be paid to the tendered amount separately
26	Within 20 days of receipt of the Letter of Acceptance, The successful Tenderer shall deliver to the Employer a security deposit in the form of TDR/FDR for an amount equivalent to 3% (As per GO No. 456 Exp 12/2022, Bangalore dt. 10-08-2022) of the contract price additional security for the unbalanced tenders (unbalanced tenders Amount Put to Tender Quoted amount) in accordance with the Conditions of Contract in the name of the Executive Engineer, KCD Division, T.
