1. Preference to Make In India products (For bids < 200 Crore):Preference shall be given to Class 1 local supplier as defined in public procurement (Preference to Make in India), Order 2017 as amended from time to time and its subsequent Orders/Notifications issued by concerned Nodal Ministry for specific Goods/Products. The minimum local content to qualify as a Class 1 local supplier is denoted in the bid document. If the bidder wants to avail the Purchase preference, the bidder must upload a certificate from the OEM regarding the percentage of the local content and the details of locations at which the local value addition is made along with their bid, failing which no purchase preference shall be granted. In case the bid value is more than Rs 10 Crore, the declaration relating to percentage of local content shall be certified by the statutory auditor or cost auditor, if the OEM is a company and by a practicing cost accountant or a chartered accountant for OEMs other than companies as per the Public Procurement (preference to Make-in -India) order 2017 dated 04.06.2020. Only Class-I and Class-II Local suppliers as per MII order dated 4.6.2020 will be eligible to bid. Non - Local suppliers as per MII order dated 04.06.2020 are not eligible to participate. However, eligible micro and small enterprises will be allowed to participate .In case Buyer has selected Purchase preference to Micro and Small Enterprises clause in the bid, the same will get precedence over this clause.

2. Purchase preference to Micro and Small Enterprises (MSEs): Purchase preference will be given to MSEs as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail the Purchase preference, the bidder must be the manufacturer of the offered product in case of bid for supply of goods. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service. If L-1 is not an MSE and MSE Seller (s) has/have quoted price within L-1+ 15% (Selected by Buyer)of margin of purchase preference /price band defined in relevant policy, such Seller shall be given opportunity to match L-1 price and contract will be awarded for 25%(selected by Buyer) percentage of total QUANTITY.

Section 9(3) Of GST

Where ever RCM is applicable, sellers (Regular GST registered seller who opted out of FCM , unregistered seller, seller registered under composition scheme)will be forced to put Zero GST and GST cess in their bids. Buyer will have liability of paying the GST and GST cess to the government on the specified rate mentioned by them in this Bid.

Buyer Added Bid Specific Terms and Conditions

1. Scope of Supply

Scope of supply (Bid price to include all cost components) : Supply Installation Testing Commissioning of Goods and Training of operators and providing Statutory Clearances required (if any)

2. Buyer Added Bid Specific ATC

Buyer Added text based ATC clauses

1 It is mandatory for all vendors to provide installation and equipment training to the schools (Principal/ATL Incharge/Faculty members) on handling and usage of equipment, after the delivery of the equipment, at no additional charge.

2 Vendor has to provide 2 years of comprehensive warranty (including a 3D printer) at no additional charge.

3 Vendor should clearly indicate the timeline for delivery of packages, installation, and training. The

Delivery time should not be more than 1 month.

4 The Vendor should maintain the supply chain of consumables and other items for 5 years.

5 The Vendor should provide 3-years of comprehensive AMC, wherever applicable, and clearly indicate the terms and conditions of the same.

6 The vendor has to indicate both itemized prices and package-wise pricing and provide detailed specifications and brand names of all the equipment.

7 The vendor should provide all required documents for verification by the school at the time of purchase of equipment. The authorized signatory must sign the documents

8 The vendor should have a mechanism for the proper disposal of e-waste.

9 In case the vendors are the third-party vendors or channel partners, they should ensure timely availability of all the equipment and associated services to the school, to avoid any delay or inconvenience to the school.

10 Vendor has to be OEM assessed by QCI or in the case of the Reseller, an OEM authorization certificate will be required.

11 Vendor should have at least a 4+ star rating.

12 Reseller/OEM must have to provide the complete ATL Package E-Content for Any Time Anywhere Learning

13 Vendors Should have Online Video Tutorials Platform for Students

14 Reseller/OEM should have experience in working with other schools and consignee's State with List of CRAC Document work completion letter should be submitted.

15 Vendor should have a representative and trainer for school staff training belonging to the consignee's state.

Disclaimer

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization. Also, GeM does not permit collection of Tender fee / Auction fee in case of Bids / Forward Auction as the case may be. Any stipulation by the Buyer seeking payment of Tender Fee / Auction fee through ATC clauses would be treated as null and void.
